HEGRA

Saudi Arabia's first UNESCO World Heritage Site. Populated since before the 1st millennium BCE, Hegra is renowned for its more than 110 remarkably well-preserved burial tombs carved from the surrounding desert rock. These tombs served as the final resting places for the Nabataean elite, with some chambers bearing inscriptions that reveal the identities of those within — healers, military figures, and local leaders.

The city's legacy extends beyond its tombs. Expertly carved stone blocks, known as betyls, stand as representations of Nabataean gods, reflecting the spiritual life of the time. Ingenious examples of ancient engineering, such as wells and stone-lined water channels, showcase the community's ability to thrive in the desert landscape. Defensive walls, gates, and towers surrounding the city reflect the influence of Roman design and the strategic importance of Hegra.

Hegra is a place where history, craftsmanship, and culture converge — a lasting testament to the ingenuity of its ancient inhabitants.

ALULA OLD TOWN

AlUla's Old Town is a labyrinth of narrow alleys and hundreds of mud-brick houses, standing shoulder to shoulder like an impenetrable fortress. These structures, shaped by time and history, date back almost a millennium. The town's winding paths and clustered dwellings reflect a settlement steeped in heritage and tradition.

Originating in the 12th century, Old Town flourished along ancient incense trading routes and played a pivotal role on the pilgrimage path from Damascus to Makkah. Its 14 gates once regulated the flow of travelers and traders, all under the watchful eye of a 45-metre-high fort, a steadfast defensive structure dating to the 10th century.

AlUla's Old Town stands as a testament to centuries of human resilience, commerce, and community, preserving the echoes of a bygone era within its mud-brick walls.

Saudi Arabia

TAYMA FORT

Situated in the expansive oasis of Tayma, Tayma Fort stands as a testament to one of the oldest settlements in Saudi Arabia and the Arabian Peninsula. This historic region, with a legacy stretching back thousands of years, was home to significant figures, including the Babylonian King Nabonidus, who took residence here in the mid-6th century BCE. Tayma is one of the few places in Saudi Arabia referenced in Mesopotamian texts, underscoring its prominence in ancient history.

The site reveals a rich narrative of power, culture, and continuity. Excavations have uncovered tools, warrior tombs from the Bronze Age, and remarkable artifacts that illuminate the lives of the people who once thrived here. These discoveries offer glimpses into a complex society that navigated the challenges of desert life with ingenuity and resilience.

Tayma Fort and its surrounding landscape continue to unveil a fascinating story of legacy, where each layer of earth holds a piece of ancient history waiting to be rediscovered.

MARAYA

Maraya, an architectural wonder in AlUla's Ashar Valley, has quickly become an icon of modern design. Meaning "mirror" in Arabic, this awe-inspiring structure features a facade composed of 9,740 reflective glass panels, allowing it to seemingly vanish into the surrounding sandstone cliffs and reappear with changing light. This optical illusion lends Maraya a futuristic aesthetic while maintaining a sense of timeless simplicity and purity.

Designed as a multi-purpose venue for concerts, events, and conferences, Maraya's connection to its environment is further enhanced by a 26-metre floor-to-ceiling facade that opens to reveal sweeping panoramic views of the Ashar Valley. A masterpiece of ingenuity and harmony, Maraya reflects not only the beauty of its natural surroundings but also the innovative spirit of AlUla.

HARRAT UWAYRID

Perched atop a volcanic mountain, Harrat Viewpoint offers one of AlUla's most breathtaking panoramas. From this elevated vantage point, gaze out over deep canyons, lush green oases, and striking rock formations stretching to the horizon. Overlooking landmarks like the Old Town and the expansive valley below, the viewpoint opens in the late afternoon, providing the perfect setting to witness the golden hues of another unforgettable Saudi sunset.

ALULA CAMEL CUP TRACK / MUGHAYRA HERITAGE SPORTS VILLAGE

Mughayra Heritage Sports Village stands as a vibrant hub for the preservation and revival of Saudi Arabia's rich sporting heritage. Nestled within AlUla's stunning landscapes, this venue

has hosted some of the most significant heritage sports events in the region. Among these is the AlUla Falcon Cup, where over 2,000 elite falconers competed, displaying centuries-old falconry skills and vying for a share of a remarkable \$16 million prize pool. The village is also home to the celebrated AlUla Camel Cup, an event honoring one of the region's oldest traditions — camel racing. This competition, known as the "Champion of Champions," draws top racing camels from around the world to showcase their speed and endurance. Through these prestigious events, Mughayra Heritage Sports Village not only honors the legacy of traditional Arabian sports but also reinforces AlUla's role as a guardian of the Kingdom's cultural identity.

DADAN

Dadan, one of AlUla's most remarkable archaeological discoveries, was once the capital of the Dadan and Lihyan kingdoms over 2,000 years ago. This ancient stone city, carved into striking red rock cliffs, features renowned tombs skillfully cut up to 50 metres above ground. Painstaking excavations have revealed Dadan's significance as a hub of trade and agriculture along the incense route. Today, visitors can explore this stunning site while archaeologists continue to unravel its secrets and inscriptions, offering a deep dive into the rich history of northwest Arabia.

ALULA OASIS

Amid AlUla's golden desert sands, lush date palm groves thrive, producing over 90,000 tonnes of dates annually and serving as a cornerstone of the ecosystem. These groves once offered shade, fuel, and shelter to merchants and pilgrims traveling to Dadan or Hegra, while supporting the livelihoods of local communities. Beneath the canopy of 2.3 million date palms, 200,000 citrus trees flourish, yielding oranges, grapefruits, lemons, and kumquats. These trees, in turn, protect aromatic herbs like basil and mint, while crops of barley, wheat, figs, and olives benefit from the region's natural spring water.

ELEPHANT ROCK

Jabal AlFil as it is known in Arabic, AlUla's iconic elephant-shaped rock, rises 52 metres into the sky, its sandstone sculpted by millions of years of wind and water erosion. At dusk, this striking formation is bathed in a magical crimson glow. Visitors can fully appreciate the spectacle by relaxing near a fire pit, enjoying food and drink, and embracing the desert's evening chill.

JABAL IKMAH

Jabal Ikmah, a treasure trove of ancient inscriptions, reflects the enduring power of the written word in human history. Etched into its cliffs and rocks, these detailed stories have inspired generations and offer a window into past civilizations. This spiritual site's significance was recognized by UNESCO, earning a place in their Memory of the World Register.

The race will take place from Tuesday, January 28th to Saturday, February 01st 2025 and consists of 5 stages. The organisation's address is:
Saudi Arabian Olympic Committee – Ad Diwam Rd, Ar Rafiah, Riyadh 12752, Saudi Arabia.

ARTICLE 2. Type of event

The event is reserved for riders from the Elite Men's Category, registered in the Asia Tour calendar with a 2.1 classification and will give points to the UCI's classifications, in accordance with articles 2.10.001 to 2.10.008 which concern stage races.

ARTICLE 3. Participation

In accordance with article 2.1005 of the UCI regulations, the event is open to:

- UCI WorldTeams
- UCI Pro Teams
- UCI Continental teams
- National teams
- UCI cyclos cross continental teams

In accordance with article 2.2.003 of the UCI regulations, the number of cyclists per team is restricted to a maximum of 7 and a minimum of 5.

ARTICLE 4. Race headquarters

The race headquarters will be open on Monday, January 27th, 2025 from 2:30 pm to 6:00 pm at the Cloud7 Residence AlUla -
AlUla 43 552 Saudi Arabia - 26°33'07.36"N - 37°56'47.39"E.

Licence-holding team managers will be able to collect race numbers from 2:30 pm to 4:45 pm.

The team manager's meeting, held pursuant to article 1.2.087 of the UCI regulations, will take place on Monday, January 27th 2025 at 5:00 pm at Prince Abdulmohsen Bin Abdulaziz park, AlUla South.

ARTICLE 5. Radio-Tour

Information on the race will be broadcasted on "Radio-Tour", using the frequency of 162,38125.

ARTICLE 6. Neutral technical support

Neutral technical support is provided by Shimano with 3 support vehicles.

ARTICLE 7. Finishing deadlines

Each stage has a finish deadline corresponding to the winner's time plus 10%.

In accordance with article 2.6.032 of the UCI regulations, the Stewards' Committee may extend finishing deadlines after consultation with the race organizer.

In accordance with article 2.6.027 of the UCI regulations, the finish of the second stage is uphill finish. The rule of the last 3 kilometers does not apply.

ARTICLE 8. Bonuses

Time bonuses, applied only to the general individual classification, are awarded for all stages according to article 2.6.019 of the UCI regulations.

They concern bonus sprints and stage finishes and are awarded as follows:

1^o) 3rd, 2nd and 1st will be awarded to the first 3 riders in the bonus sprints;

2^o) 10th, 6th and 4th will be awarded to the first 3 riders at stage finishes.

ARTICLE 9. General individual time classification

The general individual time classification is established by adding together the times recorded for each stage, taking bonuses and penalties into consideration, in accordance with article 2.6.014, of the UCI regulations.

ARTICLE 10. Points classification

15 – 12 – 9 – 7 – 6 – 5 – 4 – 3 – 2 and 1 point(s) are awarded to the first 10 riders.

The leader of the points classification will wear a red jersey the following race day.

In the event of a tie in the general individual points classification, the following criteria shall be applied in the following order, until there is a true ranking:

1^o) number of stage wins;

2^o) general individual time classification.

To be entitled to final general classification prize money, competitors have to complete the entire race within the official time limit.

**The leader of the young rider classification is the first young rider in the general timing individual classification.
He will wear a white jersey the following race day.**

ARTICLE 12. Most Active Rider classification

The Most Active Rider classification is established by adding together the points obtained in the intermediate active (MAR) and bonus sprints classifications of all stages.

Points for the intermediate active sprints classification of each stage are awarded as follows:

3 – 2 and 1 point(s) to the first 3 riders.

The leader of the classification will wear an orange jersey.

In the event of a tie in the general individual classification for the most aggressive rider, the following criteria shall be applied in order, until there is a true ranking.

1^o) number of 1st places in the different intermediate classifications;

2^o) general individual time classification.

To be entitled to final general classification prize money, competitors have to complete the entire race within the official time limit.

ARTICLE 13. Team classification

In accordance with article 2.6.016 of the UCI regulations, the team classification for each stage is established by adding together the three best individual times from each team. In the event of a tie, the winning team will be determined by adding together the rankings of their three best riders on the stage. If the teams are still tied, they shall be separated by the place obtained by their best rider in the stage classification.

The team general classification is established by adding together the three best individual times from each team in every stage. In the event of a tie, the following criteria shall be applied in the following order until the teams are separated:

1^o) the number of first places in the daily team classification;
2^o) the number of second places in the daily team classification.

Etc.

If the teams are still tied, they shall be separated by the place obtained by their best rider in the general individual classification.

Any team reduced to fewer than three riders is eliminated from the general team classification.

ARTICLE 15. Leaders' jerseys

The leaders of the various classifications are required to wear the corresponding jerseys from the sign-on until the protocol ceremony at the finish.

ARTICLE 16. Fight against doping – Doping tests

A.S.O. and all participating teams consider as an absolute necessity strict compliance with rules and recommendations issued by the authorities in the fight against doping and the obligation to observe impeccable conduct in this regard. Participating teams undertake to apply these rules and recommendations and shall be fully responsible for strict compliance by their riders and by all employees and contractors.

Doping tests shall be carried out under the authority of the ITA by designated officials, at the finish of each stage in the mobile home of the organisation.

ARTICLE 17. Protocol ceremony

After each stage, the following riders must present themselves at the protocol ceremony:

- stage winner;
- leader of the general individual time classification;
- leader of the points classification;
- leader of the young rider classification;
- leader of the Most aggressive rider classification.

After the last stage, the following riders must present themselves at the protocol ceremony:

- stage winner;
- 3 best riders of the general individual time classification;
- leader of the points classification;
- leader of the young rider classification;
- leader of the most aggressive rider classification;
- riders and the team manager of the winning team in the general team classification.

The leader in each classification must wear the corresponding leader jersey.

If a rider is first in several classifications, the order of priority in which the jerseys will be worn is as follows:

1. general individual time classification;
2. general points classification;
3. young rider classification;
4. most aggressive rider classification.

ARTICLE 18. UCI Ranking

In accordance with the provisions of Chapter X, Part 2 "Road races" of the UCI Regulations, The AlUla Tour awards points for the continental classifications.

ARTICLE 19. Penalties

Penalties are in accordance with the UCI regulations.

Article 20. Environment

A.S.O. sets up waste collection areas. Riders must only dispose of their waste, water bottles or any other object in these specially equipped areas.

Riders and followers must behave in an environmentally responsible way at all times and respect the legal provisions in force.

ARTICLE 21. Challenge – Exclusion

21.1. A.S.O. attaches great importance to safeguarding its image and reputation and those of the race. A.S.O. reserves the right to refuse participation in - or exclude from - the event, to any team or one of its members whose presence could tarnish the image and/or reputation of A.S.O. and/or the race.

21.2. Furthermore, A.S.O. may disqualify or exclude any team or one of its members from the race in the following cases:

- violation of the rules of the event, including those concerning the race's internal discipline (e. g. rules concerning accommodation);
- Serious breach of Saudi law;
- Vandalism during or outside of the race;
- Indecent dressing or inappropriate behaviour; or
- Any other act or fact that could tarnish the image and/or reputation of A.S.O. and/or the race.
- Breach of the health measures taken to combat the spread of the SarsCoV-2 virus (COVID-19).

21.3. The right of disqualification or exclusion referred to in sections 21.1 and 21.2 above shall be exercised under the following conditions:

a) A.S.O. shall advise the team of its decision in writing, by registered letter with acknowledgement of receipt or by letter delivered personally with receipt, either by fax or by e-mail.

This letter shall:

- state whether the disqualification or exclusion is related to the presence of the entire team or the presence of certain member(s) specified by name;
- specify that, if the disqualification or exclusion is linked to the presence of certain member(s) specified by name, the team must, in its capacity as employer, withdraw the member(s) from its personnel for the race or, alternatively, waive any right to participation of the entire team in the race;
- state the grounds on which it is based; and
- mention that, to challenge this decision, the team shall have a period of twenty-four (24) hours from receipt of the letter of disqualification or exclusion to file an action with the Court of Arbitration for Sport (CAS) in Lausanne, failing which the team shall be deemed to have accepted the disqualification or exclusion for good.

b) If the team has filed an action with it, CAS shall immediately appoint a single arbitrator under the expedited procedure under the Rules of Procedure of the CAS. After calling each party to evaluate its case, the arbitrator shall decide within the time limits required by urgency of the situation, whether to disqualify or exclude the entire team or certain member(s).

The language of arbitration shall be French.

The arbitrator shall decide the dispute in accordance with French law.

The arbitrator's ruling may not be appealed.

Article 22. Image rights

To enable the widespread promotion of AlUla Tour, each team, and therefore each rider within the teams, acknowledges that participation in the competition grants the organiser and its successors in title or beneficiaries cause to reproduce and display, without any compensation whatsoever, their name, voice, picture, biography and, more generally, their sports performance in AlUla Tour as well as the brand(s) of their equipment and sponsors, in any form on any material existing or in future, in any format, for any communication to the public domain, for any purpose including promotional and/or commercial use without any limitations except those specified below, and this for the duration of the protection currently given to any territory by the laws or regulations, judicial decisions and/or arbitration of any country, or existing or future international conventions, including any extensions that may be made to said duration.

However, the organisers, when allowing third parties to use pictures of the event for advertising or promotional purposes, shall not allow others to use the name, voice, image, biography or performance sports of a rider or team, nor the brand of their sponsors or equipment for a direct or indirect association between the rider, the brand of its sponsors or equipment and the product, service mark or trade name of said third party without the express consent of the rider, sponsor or supplier concerned.

Similarly, with the exception of books, photo books, comics, any form of publishing, video cassettes, CD-ROMs, DVDs or more generally any video recordings or video on any medium and format that may become the subject, is in whole or part of AlUla Tour, posters, log books, autograph books, maps, official programmes for Saudi Tour, the organiser will not carry and will not allow the exploitation of the individual image of a rider in the commercialisation of derivative products known as merchandise.

ARTICLE 23. Sports betting

In order to avoid any risk of a conflict of interest, the teams and all their members (riders, management, trainers, doctors, etc.) shall refrain from taking part in sports betting ventures concerning AlUla Tour, either directly or through an intermediary.

Article 24.

This regulation is written in French and this language version shall prevail in the event of difficulty in interpreting its terms in another language.
